## CREDENTIALS



### NEWLY ELECTED OFFICER ROSTER

- Every year, officer rosters should be submitted to the National Office, Supreme Lady, National Secretary, State Deputy, Conference President and Conference **Recording Secretary.**
- Rosters should be submitted in January every year.
- Credentials are based off the officer rosters.



### UNDERSTANDING CREDENTIALS

- Texas State Conference
  - 3 delegates allowed per court
  - Grand Lady, Jr. Daughter Counselor, 1 Elected Delegate
  - 4 delegates allowed for courts > 100 financial members
  - Grand Lady, Jr. Daughter Counselor, 2 Elected Delegates
  - List Current State Officers
  - Each delegate will present herself to Credentials
    - Present identification, receive voting cards, confirm email

### UNDERSTANDING CREDENTIALS

- National Convention
  - 4 delegates allowed per court
    - Grand Lady, Jr. Daughter Counselor, 2 Elected Delegate
  - 5 delegates allowed for courts > 100 financial members
    - Grand Lady, Jr. Daughter Counselor, 3 Elected Delegates
    - List all Current and Past National Officers
  - Each delegate will present herself to Credentials via zoom
    - Present identification and confirm email
    - On site for National Convention receive voting cards

### UNDERSTANDING CREDENTIALS

- What happens if a delegate cannot attend?
  - Vice Grand Ladies are the ONLY substitutes for Grand Ladies
  - Asst. Jr. Daughter Counselors are the ONLY substitute for Counselors
  - Alternate Delegates listed can substitute for Delegates



## SCENARIOS





### SCENARIO 1 (STATE CONFERENCE)

- Ct. 571 has 44 financial members
- The Grand Lady is also the TSC President.
- The Jr. Daughter Counselor will attend conference.
- The Vice Grand Lady was elected as a delegate.
- A total of six members are attending conference.



### SCENARIO 2 (STATE CONFERENCE)

- Ct. 612 has 78 financial members
- The Grand Lady will attend conference.
- The Jr. Daughter Counselor will not attend conference.
- There are 2 Asst. Jr. Daughter Counselors but only one is listed on the roster.
- The Assistant listed on the roster will not attend the conference.
- The 1 Elected Delegate will attend conference.



### SCENARIO 3 (STATE CONFERENCE)

- Ct. 717 has 10 financial members
- The Grand Lady will not attend conference.
- The Vice Grand Lady will not attend conference.
- They do not have a junior court.
- The 1 Elected Delegate will attend conference.



### REVIEW

- How many total votes have been lost?
- Elections have been lost or won with one vote
- Most recently the National Secretary position was won with six votes.
- One of the resolutions brought before the body last year was to make hosiery optional for turn out. • This resolution lost by 7%
- Every vote lost whether on elections or resolutions is critical.





### SCENARIO 1 (NATIONAL CONVENTION)

- Ct. 822 has 108 financial members
- The Grand Lady is a past National Officer.
- The Vice Grand Lady is attending convention and she is listed as Vice Grand Lady.
- The Jr. Daughter Counselor will attend convention.
- 2 of the Elected Delegates will attend convention and 1 of the Elected Delegates will not attend convention.
- 3 of the Alternate Delegates will attend convention.



### S C E N A R I O R E V I E W

- The goal is to ensure that no court loses their voice or vote.
- Remember to submit all credentials by the deadline.
- National Convention deadline is May 15. Submit earlier to leave time for any corrections.
- NO ONE can change credentials after the deadline.
